According to Sorrento City Council resolution n. 99 of 29/11/2011, from April the 1st to October the 31st . the City of Sorrento will introduce the tourism tax applied to non-residents overnight staying, for a maximum of 7 consecutive nights. The tourism tax per person per night is not applied to children up to 18 years old. The collected funds will help the City improve the quality of the tourist services. The tax will be paid cash directly to Sant'Anna Institute or to the hotel, apartment, B&B, or any other accommodation for non-residents.
